Eligibility This contest is open to all incoming NC State University students, enrolled students, alumni, faculty and staff, donors, employees of industry partners, and fans or enthusiasts who are 13+ years of age and are legal residents of the United States. Entry begins at 9:00 p.m. Eastern Time (ET) on 4/19/20, and ends at 11:59:59 p.m. ET on 4/24/20 (the "Entry Period").

Daily entries must be received by 11:59:59 p.m. ET of each day for the previous day's prompt.

How to Enter

- Follow @NCStateCNR on Instagram
- Follow along with the official #PackToNature Instagram Photo Challenge Calendar and take photos based on the daily prompt
- Upload it to Instagram, Stories, or direct message @NCStateCNR
- Tag it with #PackToNature
- Set your account to public so we can see it and contact you

Requirements

- Submissions may not:
 - Depict dangerous or reckless conduct
 - o Contain profanity, sexual content, illegal drugs or hateful content
 - o Promote violence or harm to another living creature
 - o Use offensive, obscene, or any other inappropriate content
 - o Defame or negatively portray any person, company, or educational institution
 - o Contain materials embodying the names, likenesses, photographs, voice or other identifying elements of any person, living or dead without written permission
- All submissions must comply with Instagram Terms of Service and Community Guidelines

General Entry Conditions Limit one (1) entry per day, per person and per Instagram account. Entries will not be acknowledged or returned.
