Rules for Recreational Users of the G.W. Hill Forest

Welcome to the George Watts Hill Forest. While you are on the Hill Forest, we expect you to obey the following rules. **Failure to do so may result in revocation of your permit with no possibility of renewal.**

1. Safety should be your main concern. This is a working forest and you should dress appropriately. Expect wild conditions. You may encounter wild animals, adverse weather, insects, spiders, ticks, chiggers, snakes, and other potentially dangerous conditions.
2. All public users must have a permit. **The permit must be displayed in plain sight while you are on the Forest.** (A lanyard and holder will be included with your permit). Not doing so is a ticketable offense, enforced by deputy patrol.
3. You will also be issued a dashboard permit for your vehicle. Please display this while parked in or near the Hill Forest.
4. Do not park where you block gates, driveways, roads, trailheads, or otherwise obstruct flow of traffic, as you may be towed at your expense.
5. No motor vehicles are permitted on the Forest without proper permission. Please park on the shoulders of County Roads and display your dashboard permit (see #3).
6. Dogs are permitted, but **MUST** be kept on leashes. Not leashed is a ticketable offense.
7. **Horse riders and bicycle riders must stay out of the Forest for at least two days following a oneinch rain.** Please consult local weather reporting stations for rainfall totals.
8. Educational uses of the Forest have priority over recreational activities.
9. Uses that disturb vegetation or soil surface conditions are not allowed.
10. All users must stay on designated trails and obey 'Trail Closed' and 'No Trespassing' signs.
11. Cross streams at designated locations only.
12. If you pack it in, pack it out. Take only pictures, leave only footprints.
13. Hooves must yield to tires, tires must yield to heels. In other words, people on foot have the right-ofway, bicycles and horse riders must yield to people on foot, and horse riders must yield to bicycles.
14. No one, except hunters, allowed in the Forest before dawn or after sunset.
15. Only hunters are allowed access to the Forest during gun season for deer and turkey. At this writing, we do not know these exact dates. Non-hunters may use the Forest on Sundays unless weather conditions preclude this use (see #7).
16. No firearms, except those carried by permitted hunters, allowed on the Forest.
17. No alcohol.
18. No illegal activities.
19. Horse Riders:
 - a. Your horse is your responsibility. If you cannot control it, do not ride on the Hill Forest. Please do not ride here until you train your horse to ride in conditions where you may meet people on foot or on bicycles.
 - b. **Take manure, hay, and/or shavings home with you.**
 - c. Do not tie horses to trees.
20. Groups wishing to use the Forest must obtain approval from the Forest Manager at least two weeks in advance of the event. This allows us to make sure that the event will not interfere with other events or education activities.
